

**University of Hyogo**  
**Global Business Course (GBC), School of Economics and Management**  
**Graduate School of Social Sciences, Department of Global Business (DGB)**  
**Alums Association Regulations**

Article 1. (Name) This Association is named "Global Business Course (GBC), School of Economics and Management, University of Hyogo / Department of Global Business (DGB), Graduate School of Social Sciences, Alums Association", commonly named: "GBC·DGB Alums Association."

Article 2. (Purpose) The GBC·DGB Alums is established

- To strengthen the bonds of fellowship and provide a platform for members to exchange helpful information.
- To enhance cooperation with the University of Hyogo and contribute to the development of the Alma Mater and society.
- To provide useful information and support in response to requests from current students.

Article 3. (Activities) In order to achieve the purpose outlined in the preceding, the University of Hyogo shall undertake the following:

- General Assembly
- Preparation and management of membership lists
- Creating and distributing a newsletter
- Holding meetings to foster friendship among members
- Other necessary activities to achieve the purpose of the Association

Article 4. (Types of Membership) The Association consists of two types of members: Regular and Special Members.

Article 5. (Membership Qualifications) Regular Members shall meet one of the requirements of Sections 1 to 3. Special Members shall meet any of the requirements of Sections 4 to 7.

- Section 1: Graduates of the Global Business Course (GBC), School of Economics and Management, University of Hyogo

- Section 2: Graduates of the Department of Global Business (DGB), Graduate School of Social Sciences, University of Hyogo
- Section 3: A person who has completed the required credits and has withdrawn from the Graduate School of Social Sciences, Department of Global Business (DGB) at the University of Hyogo
- Section 4: Faculty members of the Global Business Course (GBC), School of Economics and Management, University of Hyogo
- Section 5: Faculty members of the Department of Global Business (DGB), Graduate School of Social Sciences, University of Hyogo
- Section 6: A person who has been qualified in the past according to Section 4 or 5.
- Section 7: Other persons whom the Association approves.

Article 6. (Priority by type of membership) If a person satisfies more than one qualification as a Regular Special Member, the qualification as a Regular Member takes priority, followed by the qualification as a Special Member.

Article 7. (Admission of Members) Eligible members may join the Association by registering as a member, agreeing to the purposes of Article 2.

Article 8. (Withdrawal of Membership) Members shall be withdrawn from membership when the following reasons apply:

- Those who have applied for withdrawal
- Those who have lost their membership qualifications
- Those who are considered unsuitable for membership by the General Assembly.
- Those who have passed away

Article 9. (Officers) The Association shall have the following officers.

- Chairperson: One
- Vice Chairperson: Several
- Accountant: One
- Auditor: One

Article 10. (Officers' Duties)

- (Chairperson) The Chairperson Represents the Association and supervises the affairs of the Association.
- (Vice-Chairperson) The Vice-Chairperson shall assist the Chairperson and act on behalf of the Chairperson when the Chairperson is absent or unavailable
- (Accountant) The Accountant shall take charge of the accounting duties of the Association.
- (Auditor) The Auditor shall inspect the account and report to the General Assembly.

Article 11. (Election of Officers) The General Assembly shall elect the officers. The term of the Officers shall be two years. However, reappointment is not precluded. The term of the officer appointed to fill a vacancy shall comprise the remainder of the previous office 'holder's term.

Article 12. (Management committee members) A few management committee members may be selected from each graduating year and the current faculty, respectively.

Article 13. (Management Committee) The Chairperson, Vice-Chairperson, Accountant, and Management Committee Members shall organize the Management Committee. The Management Committee discusses the management of the Association and recommends candidates for officers to the General Assembly.

Article 14. (General Assembly) The General Assembly shall consist of a Regular General Assembly and an Extraordinary General Assembly. The Chairperson shall call 'Officers' General Assembly Meeting at least once a year. The Chairperson shall call 'Officers' Extraordinary General Meeting at the initiative of the Management Committee. The General Assembly shall discuss designing, planning, and implementing the activities of the

Association, settlement of accounts and budget approval, election of officers, revision and abolishment of regulations, and other matters. All decisions of the General Assembly require the consent of a majority of the members present.

Article 15. (Membership fees) The membership in this Association is free of charge. Changes to the membership fee amount require the approval of the General Assembly.

Article 16. (Financial year) The Association's financial year shall begin on April 1 of each year and end on March 31 of the following year.

#### Supplementary Provision

- These regulations shall come into effect from March 22, 2023.
- The regulations of the GBC · DGB Alums Association were partially revised in September 1, 2023.

第1条 (名称) 本会は、「兵庫県立大学 国際商経学部 グローバルビジネスコース (GBC) / 社会科学研究科 グローバルビジネス専攻 (DGB) Alums Association」、「(通称) GBC-DGB Alums Association」と称する。

第2条 (目的)

- ・ 会員相互の親睦を図り、有益な情報交換の場を提供する。
- ・ 兵庫県立大学との連携を強化し母校の発展及び社会の発展に寄与する。
- ・ 在学生からの要望に応じて有益な情報提供や支援を行う。

第3条 (事業) 本会は前条の目的を達成するため、次の事業を行なう。

- ・ 総会
- ・ 会員名簿の作成とその管理
- ・ 会報の作成と配布
- ・ 会員相互の親睦を図るための会の開催
- ・ その他本会の目的を達成するために必要な事業

第4条 (会員の種別) 本会は正会員、準会員、特別会員という2種類の会員から構成される。

第5条 (会員の資格) 正会員は、第1項から第3項のいずれかを満たす。特別会員は、第4項から第7項のいずれかを満たす。

- ・ 第1項 兵庫県立大学社会国際商経学部グローバルビジネスコース (GBC) の卒業生
- ・ 第2項 兵庫県立大学社会科学研究科グローバルビジネス専攻 (DGB) の修了生
- ・ 第3項 兵庫県立大学の社会科学研究科グローバルビジネス専攻 (DGB) 単位取得満期退学者
- ・ 第4項 兵庫県立大学国際商経学部グローバルビジネスコース (GBC) の教員
- ・ 第5項 兵庫県立大学社会科学研究科グローバルビジネス専攻 (DGB) の教員
- ・ 第6項 第6項もしくは第7項によって過去に資格を得た者
- ・ 第7項 その他本会が認めた者

第6条 (会員の種別の優先) 正会員、特別会員の複数の資格を満たす場合は、正会員としての資格が優先され、次いで、特別会員としての資格が優先される。

第7条 (会員の入会) 会員の資格をもつ者が、第2条の目的に賛同し、会員登録をすることで本会に入会することができる。
